2. Budget & Funding

- Randall Smith provided an update on Forest Service funding for FireScape: Catalina & Rincon Mountains for 2010 and 2011. \$270,000 has been approved with an additional \$30,000 per year for the next three years being requested to fund a 50% FTE from The Nature Conservancy (Brooke Gebow). This along with other funding requests for additional CNF mountain FireScape plans are waiting for results.
- Don Falk provided a detailed budget for July, 2009 through June 2012 asking the Steering Group for review and approval. The group approved the budget for Don to submit and implement.

3. Program Manager Position

 Brooke Gebow will become the program manager for FireScape. Brooke has requested input from all Steering Group members to provide feedback on the role and responsibilities of this position no later than July 17th.

4. Webmaster Position

Don proposed the idea of having Mickey Reed, an SNR contracted employee serve as the FireScape webmaster. Mickey had been instrumental in assisting Jim Malusa in setting up the mapping website and is already knowledgeable of the FireScape project. Lori to set up meeting with Steve, Don, Lori & Mickey to discuss Mickey's interest and availability.

5. Event Sequence and Timelines

■ Each Steering Group member was asked at the last meeting to submit steps, objectives and timelines for each segment (Compliance, Science, Engagement & Implementation). Steve submitted the Engagement portion. The remaining segments are due by the August 5th meeting.
